4. Any member who shall be **two years in arrears** of subscription shall be deemed to have **ceased** to be a member. Lapsed members are welcome to rejoin at any time.
5. Please provide your **Membership Number** in all correspondence, especially when renewing your subscription. The final year of any Membership Subscription paid in advance is shown at the end of your membership number. EG (5187/23).
